The Secretariat of the United Nations presents its compliments to the Permanent Representatives and Observers to the United Nations and wishes to convey the following:

The restrictive measures contained in paragraphs 3, 4 and 6 (c) and (d) of Annex B to resolution 2231 (2015) applied until the date eight years after Adoption Day of the Joint Comprehensive Plan of Action. Adoption Day occurred on 18 October 2015.

As a consequence, in connection with paragraphs 6 (c) and (d), the Secretariat has removed on 19 October 2023 from the Security Council website the list of 23 individuals and 61 entities subject to the aforementioned restrictive measures.
